

# Pareturn Barwon Listed Private Equity Fund

## Fund Summary

In November 2012 Barwon launched the Pareturn Barwon Listed Private Equity Fund (the Fund), a Luxembourg-based UCITS Fund, to offer UK & European investors access to the strategy it has successfully run for Australian investors since June 2007.

### Our Investment Approach

Concentrated Portfolio	The Fund holds a concentrated portfolio of 20-25 LPEs and PE backed public companies. As a UCITS vehicle the Fund complies with the 5/10/40 rule.
Actively Managed	Targeting LPEs that offer the highest risk adjusted returns based on detailed bottom-up research of the underlying investments.
Deal Stage Exposures	While no investment guidelines apply to deal stage, the portfolio is appropriately diversified across: Large LBOs, mid-and small-LBOs, growth capital, venture capital, mezzanine and junior debt, distressed and turnaround.
Geographic and Vintage Year Diversification	While no specific investment guidelines apply to geographic diversification, the majority of the portfolio (90%) is in developed Europe & North America. The portfolio is appropriately diversified across vintage years.
