#### Private Equity Returns

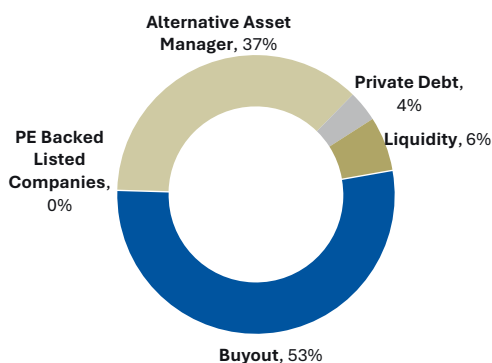
Private equity outperforms public equity. Underlying Fund aims to outperform public markets by 3% p.a. over the medium term.

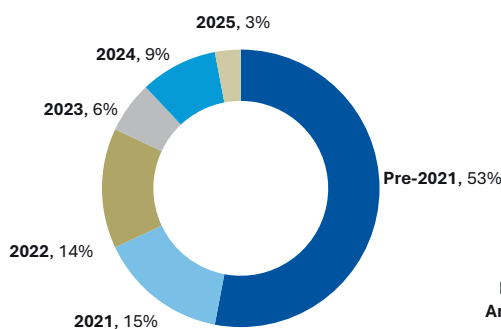

### Underlying Investment Exposures on a Look Through Basis

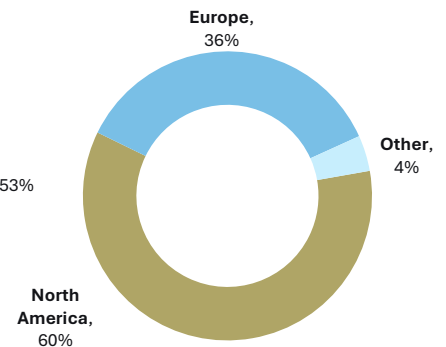
#### Investment Classification
